



The COVID-19 pandemic has had an impact on much more than just health. Across the country, communities of color have taken the biggest hit across all areas of daily life, especially in health and economic stability. Elderly and those with pre-existing conditions have also been particularly vulnerable to the virus. In Victoria County, where almost half the population is Latino, we see increases in unemployment and COVID death rates that are both higher than the State and national levels. During this time state and local governments have been allocating funds to assist their residents. \$3,566,653 of the fiscal year 2020-2021 budget for the City of Victoria was allocated to a COVID-19 fund. See below how Victoria residents have been affected by the COVID-19 pandemic and the population demographics within the County of those that are made vulnerable by age or systemic and socio-economic policies and issues.








UNDERLYING CONDITIONS—CAUSE OF DEATH













Unemployment Claims by Month, 2019 and 2020 Victoria County


Unemployment Rate January 2019 - November 2020 Victoria MSA






SNAP Eligible 2019 - 2020
Victoria County




SNAP Cases 2019 - 2020
